Remarks

- ◇Passport valid for at least one month required by all, except △ and nationals of Hong Kong (SAR) who have a Hong Kong Identity Card (HKIC).
- △No visa is required for citizens of China in possession of One-way or Two-way Permit (「單程或雙程通行證」), passport or other travel documents issued by the authorities of the People's Republic of China (PRC)
- *Hong Kong Permanent Identity Card holders are required to apply for a “Private Travel Pass to Mainland for Hong Kong and Macau Citizens” (「港澳居民來往內地通行證」)

II. Visa Application to Hong Kong

All students who do not have a right of abode in Hong Kong are required to obtain a student visa to Hong Kong to enable you to study at the University of Hong Kong. Students from overseas can choose to lodge their student visa application at least two months in advance via the local Embassies/Consulates of the PRC OR via the Centre of Development and Resources for Students (CEDARS) of HKU [3/F, Meng Wah Complex, The University of Hong Kong (phone: +852 2859 2305; Email: cedars@hku.hk)]. All applicants should nominate the CEDARS as the visa sponsor. A cost recovery fee is charged for each application for visa sponsorship.

III. Visa Application to Macau

1. According to Section I - Visa Requirements for Entering into Hong Kong / Macau / China on page 1, only the passport holders of Nigeria be required to obtain a Visa for entering Macau. The Individuals requiring a visa may obtain it [Autorização de Entrada (“Visto à chegada”)] from the Immigration Services through the local Embassies/Consulates of the PRC, for a fee of USD30, OR upon arrival in Macau at the Immigration Services for a period of 30 days, for a fee of MOP100.

2. Provided below is the additional information in the case that you do not fall into any categories mentioned:

The individuals, in possession of a Private Travel Pass to Hong Kong and Macau (「往來港澳通行證」) which only attains exit endorsement to Hong Kong (「赴港簽注」), are permitted to enter Macau only if they:

- enter Macau directly from Hong Kong; and
- period of stop over in Hong Kong of the time (for example 5 days) is less than the period the permit issued allows (for example 7 days).

IV. Visa Application to China

1. Application for visa to China could be acquired at the local Embassies / Consulates of the PRC (Please visit << <http://www.fmccprc.gov.hk/eng/> >> for details).
2. Make sure that you have obtained a Double-entry or Multi-entry visa to China as students will fly from Hong Kong to Shanghai, and Seoul via Shanghai to Hong Kong on your return trip.
3. Enclosed please find a sample to guide you in completing the numbered sections of the application form for your reference.
4. Students shall take note of the following:
 - A 2-inch recent photo (in six months) is required.
 - Applicant's passport should be valid for at least 6 months and have blank visa page.
 - The application for a visa may be declined if the applicant fails to provide with true, clear and complete information.

V. Visa Application to Seoul

1. Application for visa to Seoul could be acquired at the local Embassies (Please visit << <http://hkg.mofat.go.kr/index.jsp> >> for details).
